



CONSENT FOR OPTING THE TRANSPORT FACILITY

(TO BE FILLED-UP FOR THE ACADEMIC YEAR (2025-26))

- 1 Clearly discuss and understand the routes with the transport in-charge. The school has already designated stops at all the routes. The route will not be altered upon any request of the parent. Door to door pick up and drop request cannot be entertained as the school transport will have to follow a designated route. Cooperation is anticipated.
2. The transportation facility needs to be availed for drop as well as pick up. **One sided route facility won't be provided.**
3. Once finalized, the pick-up and drop point would remain same for the entire academic year. **In case of change in residence**, the parent will have to give a written application about the same at least a week before. The request is subject to approval depending upon the new route and seat availability in the new route requested. Parents are supposed to cooperate with the situation, in case of unavailability.
4. **School transportation fee is divided in 4 equal instalments that needs to be paid along with the tuition fee.** Kindly note that In case of cancelation due to any unavoidable reason, fee for that particular quarter has to be paid.
5. Since the seats are limited and availing the transport facility is on first come first serve basis, **no cancellation or registration of the transportation service will be entertained in between the 4 quarters.** Example: If the student has not opted for transportation facility for the month of April (1st quarter), he/she would be able to avail the transportation facility from the next quarter i.e, July, depending upon the availability of seats.
6. If the parent or guardian of the student of Nursery to Grade III is not present to drop their ward at designated bus stop, the bus driver would not wait and will bring the student back to the school.
7. **Students of X and XII** (availing transport), have to cover up the **transportation fees** for the entire session, within the **time period of 3 quarters** i.e., April to December.
8. Kindly note that the transport facility cannot be opted only for a particular quarter especially during the monsoon season. Any parent specially requesting for the transport facility during the monsoon would only be granted if there is availability of the seats only under special consideration.

I have gone through all the terms and conditions of transport facility mentioned above and

I tender my acceptance to above mentioned terms and conditions. I assure to the school management that my child will behave and maintain discipline during the entire travel time.

I hereby declare and give my complete assurance to comply with it, in case of any misbehaviour from my ward, the school has complete authority to take strict action against my ward.

My child will obey all the rules formed by the transport in-charge to ensure the safety of the students traveling in the school vehicle. In advent of any indiscipline, I understand that my child would not be allowed to avail the facility. I understand that the bus driver has to maintain the particular speed to ensure the safety of students. In case of any unavoidable delay, I would not blame or argue with the driver or the transport facility.
